Central Atlantic Region

The Central Atlantic Region of NA consists of 17 areas and has meetings in Virginia, West Virginia, Maryland, and North Carolina. Since our last Zonal meeting we have had two conventions. The Almost Heaven convention was held August 3rd – August 5th in Front Royal, VA. We just had our 31st Regional Convention January 11 – January 13th in Roanoke, VA. Both of these conventions were well attended and a good time was had by all. Our delegate team put on a presentation at the Regional Convention titled NA Around the World, Our Global Fellowship. We showed videos, psas, and interviews with addicts from Cuba and China. We also went over the results of our last Membership Survey. Our subcommittees have been struggling with attendance but have still accomplished a great deal. H&I made a presentation at Lunenburg Correctional last fall and is still working on developing Writing Steps in Recovery which will bring step work to incarcerated addicts. PR wants to develop presentations to carry to the 4 quadrants in our region. Four areas in our region, New Dominion, Beach, Peninsula, and Tri-Cities are putting together a bid for the East Coast Convention. There was a motion sent back to areas to decide whether Central Atlantic will provide a letter of support. These areas are very excited to bring the East Coast convention to Virginia as it has never been held there before. Our region consists of 4 areas; Bucks, Montco, Pure and Simple and Twin Rivers. Our areas make up part of the eastern portion of Pennsylvania, north of Greater Philadelphia Region and Twin Rivers has some meetings in New Jersey (Philipsburg).

All four areas have made a decision to remain with Eastern PA. At our December elections, most of our positions, with the exception of RD and RDA, have been filled. Public Information has been working towards becoming a Public Relations Sub-Committee. We plan on working with H&I at our next RSC to explore this direction. The committee has been discussing this for the past 2 RSC meetings, and will make a decision soon regarding this change.

We have been updating our phonline lists to keep them current, checking to see if those on the list are still interested in participating, and offering phonline orientation to others who have not yet been oriented. We are also using a rotation system so that the same people are not always being called (those at the top of the list). Between November and January 24, 2013, our phonline received 148 calls.

We held our regional inventory, and then followed up with the Planning Basics Tool.

Twin Rivers Area is working toward a potential Metro committee to coordinate H&I and PR committee efforts within the Lehigh Valley including the Pocono Mountain and Little Apple Areas. These three areas are geographic neighbors yet are participants of different Regions. To date there has been a lot of interest and positive feedback on the subject.

We have been contacted by the Marietta Georgia WSR (Writing Steps In Recovery) Committee. They were wondering if there are any other WSR groups in PA? They are getting requests from PA Prisoners and are handling the requests for now, but would like to connect and coordinate with any other WSR committees. This will be brought up at our next RSC meeting, but we would like to discuss with other regions if they have WSR committees, and how they are doing.

The Mountaineer Region currently supports 10 Areas with about 150 meetings around the state and

we continue to grow at a steady pace. We understand that our numbers are not at the level of many

regions in our Zone however, the Mountaineer Region is carrying a strong message of NA recovery.

At our Fall Mountaineer Regional Service Forum we had a discussion on the following topics: Zonal

Representation and the roles our Zone can play to better support our Regions.

We had a more thorough

discussion at our last RSC earlier this month and have brought some ideas from our Regional members

to the table today.

Our phonenumber is functioning very well; we are using One Box answering service to send every call

directly to a recovering addict's cell phone. Phonenumber members are on a 4 hour rolling weekly schedule

and this continues to work out great. We are averaging about 200 calls per month with approximately

50 volunteers answering direct calls. We also have nearly 100 volunteers as contacts in their Areas. Our

phonenumber chair has been busy doing workshops across the Region and we are constantly having new

members signing up to be of service.

Our Areas currently host 15 H&I commitments across West Virginia and Southeastern Ohio and we

continue to inventory how H&I on a Regional level can support these current commitments. Our PR

efforts continue to grow as well.

The Mountaineer Region hosts two conventions annually. Our Spring Convention this year has been

moved to the weekend after Mother's Day weekend and will be held on May 17th-19th at Cedar Lakes in

Ripley, WV. The convention is held in a beautiful outdoor environment with 3 lakes, a lodge, and other

multiple buildings with dorm style and hotel style rooms. Our Regions hosts the Mountaineer Regional

Service Forum at every convention in order to present and discuss service related issues.

Our Areas continue to host too many function to mention, but there has been an increase in service

learning days as the interest in service from our newer members continues to grow, and we continue
