End of Voting Process

** Personal Note: This (above) process took up a day and a half due to a long pointless debate over minutiae about whether or not a WB member could make a friendly amendment to a motion during a meeting of the entire WSC only to clarify the said motions' intent to be congruent to the motion itself after it has already been presented to the membership at large, and voted on from group level, to area level, and to regional level prior to us being doing the business of WSC.

It truly became one of those momentary things that occasionally come up in doing service that can make service work actually feel uncomfortably dis-Unified and mentally and emotionally trivializes our goals and makes one question within oneself the point of why myself or anyone else wants to voluntarily do this work. Should it extend into a long term habit it becomes difficult to find service volunteers. I've been in a few of those service bodies-even here in this room, and I'm so blessed & truly Grateful YOU Folks currently in This Room are doing the work of Our Region with love and respect for our common

good and are of the mind and motivation toward service motivated in the Goal of helping one more addict in our neighborhood to find recovery.

Fortunately, within a half hour or so of day 2 common sense and rational loving hearts prevailed and we moved on. The friendly amendment was withdrawn, and a consensus that the intent was in reality clear enough to make it clear that what we'd all voted on back home matched the intent, we voted, it passed, and we moved on unified once more.

Continuing to Discussion topics:

Our remaining hours of that remaining day and those next weekend days during our Spring Convention were full conference and smaller breakout group discussions on the following topics:

- 1. Pros & Cons of Moving to a 3-Year Cycle of WSC rather than the current 2-Year Cycle.

- 2. Opt-In Funding.
 - A. Ideas stemming from the fact that many Regions are funding their own RD's to WSC.
 - **B.** Any Region requesting Funding would receive it rather than regions opting out.
- 3. How can we use the time between meetings more effectively?
- 4. What needs to be or benefits from being discussed at an in-person conference and what can be done virtually?

Who could attend virtually?

We had a couple of information presentations which I didn't download basically because they were in PowerPoint Presentation form and because one was presented by non-English speaking folks who were interpreted well, but my discussion of their presentation would do no justice and be un-interesting at best to the Committee.

Briefly, however, the subject discussed was intended to get <u>us</u> discussing & addressing gaps in our fellowship development and outreach and how we might develop a better strategy to fulfill closing the gaps.

Next a gentleman discussed his regions' mode of mentoring their future service people teaching positional responsibilities for any position from GSRs to RCMs, Regional Officers, Committee memberships, RDs, etc. the process begins with sponsorship

modeling service as desirable for enhancing ones own recovery processes, and recruitment of members showing promise into a sort of pre-training in things like "Guide to Local Service", "12 Concepts for NA Service", "Guide to World Services in NA", etc. We may think about developing some sort of mentoring program and attracting service people from our home group members if we wanted to get rotating service members rather than doing all the jobs ourselves until we burn out.

Lastly, it would appear that the Iranian Region has decided to withdraw from NAWS. I've attached some communication between WB and Iran folks and I know that more will be revealed in time.

It's an honor and privilege to serve our region and I thank you for the opportunity. You folks make service enjoyable, and I try expressing that whenever the opportunity presents itself when I'm associating with our membership outside our service body. Just wanted to let each of you know that.

The completed Finance Template in the Appendix shows the progress of discussion during the committee meeting. The balance coming into Regional Service is the starting balance, standard quarterly expenses are subtracted; donations and reimbursements are added. Already encumbered money is subtracted. Money proposals are listed and totaled, then subtracted to determine if there is money to cover those proposals; we decided not to support the WV OMA Conference or the Addiction Professionals Conference as the cost was prohibitive. During discussion, we reviewed the Regional Policy to determine if there are other money items to be considered. There were not. The bottom line was that if the recommended proposals passed and all bills and expenses were paid, we will still have over \$1,000 left over. The committee recommended the money motions be sent on to the RSC for consideration.

It was decided to do the annual financial audit of the treasurer's books and bank account in October this year as the books will be transferred to the new treasurer at the October Region.
