We represented MRSCNA at the NASW West Virginia Spring Social Work Conference which was held on May 3-5, 2023 in Charleston. Our display was set up and attended by David C. and I from NANA and Joe B. and Liz F. from Metro. Joe was especially helpful as he had experienced this event before. We had 69 documented visitors. 21 of them left contact information (we also got 22 likes). David and I also sat on a "Mixed Recovery Panel" in a sort of meeting demonstration along with members of AA, AI Anon, and a gentleman who had an alternative path to recovery. We did our best to clearly define NA without stepping on any toes. The purpose of this workshop was to show the Social Workers what their clients could expect at a meeting. During the Q & A the subject of Medically Assisted Treatment came up. The consensus among the panel members was that while it could be a useful means to an end it was not a permanent solution. I also had the opportunity to visit other tables, answer questions about NA, and learn more about how other organizations are trying to help people. I would recommend this kind of service work to any NA member who wants to broaden their horizons.

Hi Friends, Merchandise at the Spring Convention started off a little weird, but once the merchandise arrived in Ripley all was well. We were able to get a lot of help from a lot of different people on Friday and I am grateful for that. Going the route we did with Tish ordering the merchandise and printing it herself before and during the convention was beneficial in some ways, however I am not sure it was easier than the way we had previously done it. We do have some leftover inventory that was printed (7 tank tops, 18 t shirts, and 7 crewneck sweatshirts) that will be sold at the next convention at a discounted rate. We sold all tie dye merchandise the fastest. We have a significant amount of mugs left over. I have listed some pros and cons below.

Pros: Cheaper! Way more items for less money. We have a significant amount of blank inventory (hoodies and crew neck sweaters) for the next convention so we will need less money for the fall. We are able to print on site, however I think this opens the door for more confusion and more to keep track of.

Cons: All of the work is on one individual. All of the leftover blank merchandise had to be taken back with Tish (or wherever it went) and has to be stored until the fall. This seems to create a burden for more than one person. It was nice in previous conventions to sell out and be done with one convention and be able to move into the next one. Now, we have a lot more to keep track of as we have the leftover inventory.

Motion 1. Continuation of the suspension of Article 5 Section 3 of FIPT Operational Rules with the suspension expiring at close of WSC 2023. (Our Vote was NO {2-yes, 1-no, 4-abstentions}) Final Tally was 107-yes 1-no 4-present/not voting \*Motion passed

Motion 2. To extend terms of the WSC elected positions for the two (2) Human Resource Panel members set to expire in 2022 to 2023. (Our vote Yes {4-yes; 3- abstentions}) Final Tally was 115 Yes, 0-No, 1-Abstention \*Motion passed

Motion 3. To extend the terms of the 3 elected positions on the World Board currently set to expire in 2022 to 2023 (Our vote: Yes {4-yes, 3-abstentions})

Final Tally was 117 yes, o-no Unanimous Motion Passed

Motion 4. To approve "A Spiritual Principal a Day" publication as 'Fellowship Approved recovery literature (Our vote: No [3-Yes, 1-no, 3-abstentions) Final Tally was 109-Yes, 2-no, 1-abstentions (RD's only) Motion Passed [side note: Zonal

Delegate separate vote was 5-0 in favor

**End of Voting Process** 

\*\* Personal Note: This (above) process took up a day and a half due to a long pointless debate over minutiae about whether or not a WB member could make a friendly amendment to a motion during a meeting of the entire WSC only to clarify the said motions' intent to be congruent to the motion itself after it has already been presented to the membership at large, and voted on from group level, to area level, and to regional level prior to us being doing the business of WSC.

It truly became one of those momentary things that occasionally come up in doing service that can make service work actually feel uncomfortably dis-Unified and mentally and emotionally trivializes our goals and makes one question within oneself the point of why myself or anyone else wants to voluntarily do this work. Should it extend into a long-term habit it becomes difficult to find service volunteers. I've been in a few of those service bodies-even here in this room, and I'm so blessed & truly Grateful YOU Folks currently in This Room are doing the work of Our Region with love and respect for our common good and are of the mind and motivation toward service motivated in the Goal of helping one more addict in our neighborhood to find recovery.

Fortunately, within a half hour or so of day 2 common sense and rational loving hearts prevailed and we moved on. The friendly amendment was withdrawn, and a consensus that the intent was in reality clear enough to make it clear that what we'd all voted on back home matched the intent, we voted, it passed, and we moved on unified once more.

Our remaining hours of that remaining day and those next weekend days during our **Spring Convention** were full conference and smaller breakout group discussions on the following topics:

- 1. Pros & Cons of Moving to a 3-Year Cycle of WSC rather than the current 2-Year Cycle.
  - A. How do we get work done in a timely manner.
  - B. How can Zonal Forums be more fully used?
  - C. Can we use Annual or bi-annual WSC Digital meetings?
- 2. Opt-In Funding.
  - A. Ideas stemming from the fact that many Regions are funding their own RD's to WSC.
  - B. Any Region requesting Funding would receive it rather than regions opting out.
- 3. How can we use the time between meetings more effectively?
- 4. What needs to be or benefits from being discussed at an in person conference and what can be done virtually?
  - 5. Who 'Needs to attend the in-person meetings in the future? Who could attend virtually?

We had a couple of information presentations which I didn't download basically because they were in PowerPoint Presentation form and because one was presented by non-English speaking folks who were interpreted well, but my discussion of their presentation would do no justice and be un-interesting at best to the Committee.

Briefly, however, the subject discussed was intended to get us discussing & addressing gaps in our fellowship development and outreach and how we might develop a better strategy to fulfill closing the gaps.

Next a gentleman discussed his regions' mode of mentoring their future service people teaching positional responsibilities for any position from GSRs to RCMs, Regional Officers, Committee memberships, RDs, etc. the process begins with sponsorship modeling service as desirable for enhancing ones own recovery processes, and recruitment of members showing promise into a sort of pre-training in things like "Guide to Local Service", "12 Concepts for NA Service", "Guide to World Services in NA", etc. We may think about developing some sort of mentoring program and attracting service people from our home group members if we wanted to get rotating service members rather than doing all the jobs ourselves until we burn out.

Lastly, it would appear that the Iranian Region has decided to withdraw from NAWS. I've attached some communication between WB and Iran folks and I know that more will be revealed in time.

It's an honor and privilege to serve our region and I thank you for the opportunity. You folks make service enjoyable and I try expressing that whenever the opportunity presents itself when I'm associating with our membership outside our service body. Just wanted to let each of you know that.
